

**ORDINANCE NO. 1005
TAX LEVY ORDINANCE**

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES FOR THE CURRENT YEAR COMMENCING ON THE FIRST DAY OF MAY, 2017 AND ENDING ON THE THIRTIETH DAY OF APRIL, 2018 FOR THE CITY OF EL PASO, WOODFORD and McLEAN COUNTIES, ILLINOIS.

BE IT ORDAINED by the Mayor and City Council of the City of El Paso, Illinois as follows:

SECTION ONE: That a tax for the following sums of money, or as much thereof as may be authorized by law, to defray all expenses and liabilities of the City of El Paso, be and the same is hereby levied for the purposes specified against all taxable property in the City of El Paso, Illinois, for the fiscal year commencing on the first day of May, 2017 and ending on the thirtieth day of April, 2018.
