2015 NUTLEY IRISH AMERICAN ASSOCIATION "MEMBER OF THE YEAR"

WHEREAS, Joseph M. Milbauer of New Providence, New Jersey, has been named by the Nutley Irish American Association as its 2015 "Member of the Year" in recognition of St. Patrick's Day and the 2015 Nutley St. Patrick's Day Parade, which will be held on Saturday, March 7, 2015; and

WHEREAS, Joseph M. Milbauer will be honored during the Nutley Irish American Association's 37th Annual Grand Marshal Dinner to be held on Friday, January 30, 2015, at Nanina's in the Park in Belleville, New Jersey; and

WHEREAS, Joseph M. Milbauer traces his Irish ancestry through his paternal grandmother, Katherine Kearney, whose family roots are in County Meath; and

WHEREAS, Joseph M. Milbauer, one of four children born to the late Frank and Joan Milbauer, grew up in New Providence and graduated from New Providence High School before going on to earn an Associate's degree in Humanities and Social Science from the County College of Morris and then a Bachelor's degree in Political Science from Lynchburg College, where he was a member of the Delta Chi Chapter of Tau Epsilon Phi and currently serves on the Planning Committee for the Greg H. Holland Scholarship Fund; and

WHEREAS, following his graduation from college Joseph M. Milbauer interned with the Contract Service Association of America in Washington, D. C., where he was a lobbyist dealing with issues of contracted work conducted on U. S. military bases both at home and abroad. He also earned a Certificate in Paralegal Studies from FDU-Madison and worked as a Litigation Paralegal at Paine-Webber before becoming a licensed Insurance Agent in May of 1998 and embarking on his career in the insurance industry; and

WHEREAS, Joseph M. Milbauer first worked for New York Life Insurance Company and then joined Park Insurance Associates, Inc., of Nutley where he worked as a broker for 13 years, from September of 1999 to February of 2013, during which time he joined the Nutley Irish American Association in 2007, immersed himself in the community as an active member of the NIAA, and enthusiastically explored his Irish heritage; and

WHEREAS, Joseph M. Milbauer joined ADP in Florham Park in 2013, where he currently serves as a Remarketing Specialist in the Insurance Division. That same year he also incorporated his own firm, J. M. Milbauer Solutions, LLC; now, therefore, be it
