**WHEREAS**, the County's Office of Purchasing recommends the Board of Chosen Freeholders award the contract for the Goods to Atlantic Tactical, Inc., pursuant to, and upon the terms of New Jersey State Contract No. 1NJCP81297; and

**WHEREAS**, the Chief Financial Officer has certified the availability of funds to pay such contract (which certification is attached hereto); and

**WHEREAS**, Atlantic Tactical, Inc., is in compliance with Ordinance # O-2015-00014 now, therefore be it

Subject: Winchester Brand Ammunition for Correctional Facility Personnel  
As per New Jersey State Contract 1NJCP 81297 expires: 4/30/16

**Introduction:**

The Essex County Department of Corrections has requested to purchase Winchester Brand Ammunition for their use in law enforcement. In accordance with the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) any contracting unit may without advertising for bids purchase any goods or service under any contract entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury. In response, the following information has been obtained:

This Commodity requires a separate resolution as per the Board of Chosen Freeholders

**Recommendation:**

After reviewing and verifying the terms and conditions of the NJ State Contract it is recommended that the Board of Chosen Freeholders authorize by resolution payment to: Atlantic Tactical of NJ, Inc. 763 Corporate Circle New Cumberland, PA. 17070.

**Reason for Recommendation:**

The Essex County Department of Corrections has decided to procure this equipment using the cooperative agreement from the New Jersey State Contract. This is being presented to the Board of Chosen Freeholders as per their request to approve separately purchases regarding law enforcement products. This purchase would normally be processed through the omnibus resolution. The Board of Chosen Freeholders have requested to review and approve all purchases within this law enforcement commodity.

**Fiscal Impact:**

Funding for this body armor will be from Operating Account#101-4201-423-2500 (2016) . This purchase shall not exceed \$26,835.00.

**Alternative:**

The alternative would be to advertise for bids, but the State of New Jersey has extended this bid as a cooperative to the local municipalities if they wish to use this method of procurement.

**History:**

The County of Essex has purchased law enforcement products from this vendor in the past using the New Jersey State Contract. This method also keeps these purchases discreet for the safety of our law enforcement personnel.

**Conclusion:**

The Essex County Department of Corrections has the option to use this method of procurement to purchase this ammunition within compliance of the Local Public Contracts Law.

Please accept this letter as a response to Essex County's questions regarding the sale of rifles, handguns and ammunition.

1. *What initiatives, if any, have you undertaken to combat illegal gun trafficking and illegal crimes?*

Atlantic Tactical does not manufacturer firearms or ammunition. As a dealer, we have instituted several policies with the purpose of minimizing the chance that one of our firearms will fall into the wrong hands.

First and most importantly, Atlantic Tactical only sells firearms to Public Safety Agencies and Personnel. We do not sell firearms to the general public.

Second, Atlantic Tactical conducts significant training of our staff on how to identify potential straw-person transactions. We deny any sale where we have reason to believe that the person purchasing the firearm is doing so for a third party. We have also retained a consulting service called FFL Guard to help advise on how to implement best policies.

Third, Atlantic Tactical employs a large number of retired Law Enforcement officers who based on their previous experience, have a vested interest in keeping firearms out of the wrong hands.

Fourth, Atlantic Tactical has installed significant physical and electronic security devises to safeguard the firearms inventory at our stores.

2. *Do you manufacture and sell assault weapons for civilian use, other than for the purpose of target, as allowed NJSA 2C:58-12a.?*

Atlantic Tactical does not manufacturer firearms. Our company policy limits firearms sales to Public Safety Agencies and Personnel. We do not sell firearms to civilians.

3. *What polices do you have in place to ensure that your dealers require permits to*



*purchase handguns, firearms purchaser identification cards and/or required certification in writing as well as other forms of identification required by law before selling firearms to customers*

Atlantic Tactical is a dealer and does not manufacture firearms or ammunition. Atlantic Tactical and its employees adhere to all Federal, State and Local laws. All gun sales require necessary identification and permitting as stipulated by the various laws in each state.

All Atlantic Tactical firearm sales are subject to two additional checks by supervisors to ensure the documentation is completed correctly and the necessary ID's were collected.

4. *Do you fund research related to gun violence and smart gun technology.*

Atlantic Tactical is a dealer and does not fund product research of any kind.

5. *Will you commit to advocating for less violent content in video games by reducing the amount of firearms usage in them to a minimum?*

As Atlantic Tactical is not a manufacturer of firearms, we have no control over images of firearms or their use in video games.

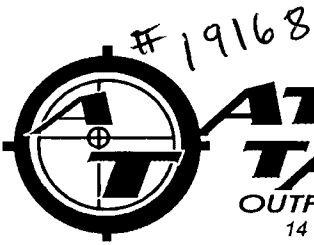
