RESOLUTION CREATING A MOSQUITO CONTROL COMMITTEE

WHEREAS, the Essex County Board of Chosen Freeholders wishes to establish a committee to review those issues concerning mosquito control within the County of Essex; and

WHEREAS, pursuant to the Optional County Charter Law N.J.S.A. 40:41A-86 and Article 2, Section 2.16 of the Code of the County of Essex, the Essex County Board of Chosen Freeholders is empowered to establish committees; and

WHEREAS, pursuant to Article 2, Section 2.10B of the Code of the County of Essex, the President of the Board of Chosen Freeholders is empowered to appoint members of such a committee; now, therefore, be it

RESOLVED, by the Essex County Board of Chosen Freeholders that there be and there is hereby established a Mosquito Control Committee; and, be it further

RESOLVED, that said Committee shall be comprised of four (4) members of the Board of Chosen Freeholders, one of whom shall be designated by the President of the Board as Chairperson of said Committee; and, be it further

RESOLVED, that this Committee shall report its findings to the whole Board, in writing, within one (1) year from the date of this resolution; and, be it further

RESOLVED, that upon issuance of said Committee's final report and acceptance of same by the Board of Chosen Freeholders, the aforesaid Committee shall be dissolved.
