WHEREAS, David E. Hogenauer, a resident of Crane's Mill Retirement Community in West Caldwell, New Jersey, is being remembered upon his passing from this life on Friday, April 3, 2020, at the age of 86 of complications from COVID-19; and

WHEREAS, David E. Hogenauer was a history teacher in Maplewood, New Jersey, a loving husband, father, and grandfather who gave back to his community in many ways; and

WHEREAS, David E. Hogenauer was born in Port Chester, New York, and lived in Maplewood, New Jersey, from 1964 to 2015. He received his Bachelor's degree from Haverford College and Master's degrees from Harvard University and Seton Hall University; and

WHEREAS, David E. Hogenauer was a history teacher at Columbia High School in Maplewood, New Jersey, for 32 years from 1964 until his retirement in 1996. He gave back to his community through his work with South Mountain Conservancy and leadership positions at Prospect Presbyterian Church including his church's partnership with the Interfaith Hospitality Network for the homeless; and
