WHEREAS, Robert T. Wasacz affectionately known as "Bobby Wells" was born in Brooklyn, New York, to the late Louis and Genevieve (nee: Toman) Wasacz. He lived in Rockaway, New Jersey, before settling in Bloomfield, New Jersey, 35 years ago; and

Performing all over the United States, as well as in Hong Kong, China, and Rome, Italy. He has been presented with numerous awards for his humanitarian work on behalf of disabled children and other charities. All of his band members and friends will tearfully and sorely miss him; and
