FORTY FORT BOROUGH

**AN ORDINANCE OF THE BOROUGH OF FORTY FORT AMENDING
FORTY FORT CODE CHAPTER 15, PART 1, SECTION 15-402 – PARKING
PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS**

WHEREAS, the Borough of Forty Fort, Luzerne County, Pennsylvania enacted Ordinance No. 2009-8, codified at Chapter 15, Part 1, Section 15-402 of the Borough Code, establishing certain locations on streets within the Borough of Forty Fort whereon the parking of vehicles is prohibited at all times; and

WHEREAS, the Ordinance was amended on May 4, 2015, by Ordinance No. 6 of 2015, pursuant to a paving and roadway rehabilitation project which required Forty Fort Borough to amend its Code to meet current Pennsylvania Department of Transportation regulations for parking on Commonwealth owned roadways and/or highways and on roadways and/or highways intersecting with Commonwealth owned roadways and/or highways; and

WHEREAS, Ordinance 6 of 2015 set forth a list of additional locations where parking of vehicles on roadways within the Borough was prohibited; and

WHEREAS, the Borough Council for the Borough of Forty Fort desires to again amend Chapter 15, Part 1, Section 15-402 in compliance with Pennsylvania Department of Transportation regulations.

BE IT ORDAINED AND ENACTED by the Borough of Forty Fort, Luzerne County, Pennsylvania, Chapter 15, Part 1, Section 15-402 of the Borough Code, Parking Prohibited at All Times in Certain Locations, shall be amended to prohibit parking at the following street location:

<u>Street</u>	<u>Side</u>	<u>Between</u>
River Street (SR 1006)	East	Centerline intersection of Rutter Avenue for a distance of 121 feet South.

BE IT FURTHER ORDAINED AND ENACTED as follows:

1. The Engineering firm engaged by the Borough of Forty Fort shall take all steps necessary to submit the proper documentation to the Pennsylvania Department of Transportation for their approval in the placement of signs.


2. Upon approval from the Pennsylvania Department of Transportation, the Forty Fort Borough Street Department is hereby directed, in cooperation and consultation with the Forty Fort Borough Police Department, to erect such signage as may be required by law in order to properly effect the prohibition of the parking of vehicles as provided for in this amendment.


3. The remainder of Chapter 15, Part 1, Section 15-402 of the Forty Fort Borough Code shall remain unchanged.

4. This Ordinance shall become effective immediately upon its enactment and adoption by Borough Council and shall be immediately enforceable by the Forty Fort Borough Police Department upon the erection of such signage as is required by law in order to properly effect the parking of vehicles as provided for in this Ordinance.


