#### **Comments from Assemblyman Chris Brown**

Mayor Silva opened the floor to Assemblyman Brown, who expressed his thanks for the opportunity to be accessible to local residents through his presence this evening. He also stated his congratulations to Amy Gatto, citing her as an excellent example for young females.

Assemblyman Brown acknowledged that the Township wound up spending about \$1,100.00 a day due to the lack of funding in the Transportation Trust Fund. He also stated that he is hopeful that legislation will be enacted that will require the state to reimburse the Township for costs they incurred due to the shutdown. He further stated that Hamilton Township is a model of leadership for how they managed to lower debt, maintain a stable tax rate, and still provide services.

### Malaga Road Update

Mayor Silva remarked that we've had a very serious issue out there once the Governor's Executive Order No. 210 closed down all of the state funded construction on the infrastructures. He stated that the road has been reopened as of Thursday of last week, and hopefully the safety issue has been put to rest.

Mr. Schenker and Mr. Kurtz expressed their satisfaction that the road is open. Mr. Guishard stated that he hopes that the state does reimburse Hamilton Township for that work; Mr. Kurtz agreed.

## <u>Public Hearing – Five Year Tax Exemption in the Historic District for construction of a new home (Block 741, Lot 2 – 80 Mill St.)</u>

Mayor Silva clarified that this is for the new home that is between the Masonic Temple and Victor's Liquor Store; the original home there sustained extensive damage from Hurricane Sandy. He then opened the floor for public discussion.

WHEREAS, Township Code Chapter 269, Article VI authorizes the Township to grant a five year tax exemption of thirty percent (30%) of the full true value of new construction and a five year tax abatement of existing value by twenty percent (20%) of the total cost of the new construction on certain properties within the Township; and

WHEREAS, Robert & Mary Hahn ("Applicant") is the owner of Block 741, Lot 2-80 Mill Street (the "Property"), at which property is presently located a newly constructed home; and

WHEREAS, the Applicant has completed construction on the Property (the "Construction") and timely filed an application with the Tax Assessor, such application being attached hereto and being made a part hereof; and

WHEREAS, the Tax Assessor has deemed such application to be complete and determined that Applicant has met all requirements for entitlement to an exemption and abatement for construction of a dwelling in the Township's Historic District; and

WHEREAS, the Applicant has appeared before the Township Committee, and the Township Committee has considered any testimony by Applicant and is satisfied with Applicant's responses to all questions by the Township Committee regarding the Construction;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Hamilton does hereby:

- 1) Approve the granting of a five year tax exemption and abatement to Applicant for the Construction on the Property pursuant to Chapter 269, Article VI of the Township Code; and
- 2) Authorize the Tax Assessor, Tax Collector, and Exemption and Abatement Officer to take any actions necessary and proper to effectuate this approval.

# <u>Authorization to enter into an agreement with NJ Transit for the installation and maintenance of a bus shelter on Cologne Avenue and Authorize Mayor to sign same.</u>

Mayor Silva inquired and confirmed that this matter had been previously tabled, and that there is currently nothing in writing from the property owner. Both Mayor Silva and Mr. Schenker expressed concern for the liability risk to the Township. Solicitor Sandman confirmed that the agreement calls for the Township to defend, indemnify, protect, and save harmless the State. This involves two distinct duties: payment of any judgment or settlement, and payment of attorney's fees and costs involved in a lawsuit. Therefore, signing this agreement would task the Township with defending the State in the event of a lawsuit. Mr. Guishard inquired whether this type of provision is standard for all bus shelters, and stated it is reasonable to believe that it is a standard arrangement. Mr. Guishard further stated that we have a duty to the 39 people who use the bus, and a remote risk of lawsuit should not stop the residents from having a bus shelter. Lengthy discussion ensued, and it was the consensus of the majority of the group for the matter to remain tabled until we know more about the liability issues.

#### Resolution Ratifying the Execution of the Amended Malaga Road Contract.

Comments:

Mr. Guishard: Have we assured ourselves that this new amended contract limits our liability or does not subject us to any liability?

Solicitor Sandman: Well it could, I mean as I reported the last two meetings, this is a very unusual circumstance where you have the Executive Order followed by a second Executive Order which carves out somewhat of an exception. But what you did here is first you took testimony from the Chief, followed up by a certification of the Engineer to establish that this was a dangerous condition. Then at the second meeting, there was other testimony provided by our residents, again the Chief, some by Miss Gatto, as to the further deterioration and you once again declared this to be a dangerous condition. Under the Local Finance Rules and Regulations, it required three things: it required a request from the Administrator to put this on the Agenda, it required a certification from Arawak as the contractor certifying certain things, including that this was an unforeseeable event, and a similar certification from Bob Smith, the Engineer in charge of the project. So all three of those documents should be part of the record and part of the minutes, and all of that has been satisfied. So you have, as best I can tell, complied with all of the rules of Local Finance with respect to doing what we did, what you did, but it's a new ball game. Nobody's going to tell you there's no risk; in fact, they wrote to us and said there is risk that you could lose the funding, and we had a hearing and it was determined, I think in large measure based upon public safety, to provide with finishing the contracts essentially. So there is risk, there's always risk, particularly in an area that is uncharted. Now having said that, 90% of what I do is I represent injured victims in car accident cases and other cases, and I can tell you that you are absolutely on notice of a dangerous condition. Had you not acted as you did and someone was injured or killed, you certainly would have been liable.

Upon making his motion, Mr. Schenker stated: This is something that cost us \$50,000.00, at this point it was going to keep increasing as time went on, on top of the safety issues that we discussed in previous meetings, and our Solicitor just brought up our responsibility and our liability to this situation, so I believe that the, even though I wasn't happy about the \$50,000.00 and I made my feelings clear, when they got you over a barrel, you've got to go ahead and do what you've got to do, so I think the money, I'd like to say it was well spent, but it was, it had to be spent.

Upon seconding the motion, Mr. Kurtz stated: I believe it was an issue we had to make, it was something that, it actually when it came to the point where we had to make a decision, it was pretty much a no-brainer, it was a safety issue, we had to do it, and I think it was something that, I'm happy that we made the decision. It certainly finished the road quickly, it's over now, and there's an element of safety here now for children riding the buses and everything else, and the motorists.

Mr. Guishard: I'd just like to comment since this safety thing keeps coming up, that there are ways to satisfy the safety issue. It can be done with barriers, with police, etc. The problem is it would be inconveniencing, that's for sure. So I'm not saying we made the wrong decision but this, we continually talk about safety, and safety is really not an issue. We have the responsibility for assuring safety, and we can do that even though that road is closed. Roads are closed all around the state, and the provisions properly made to make it safe. We could do that also, but we chose not to. That's all I have to say.

Mayor Silva: Interesting comment, because if you look at the fact that the Governor may not even act on this until after November 8<sup>th</sup>, and maybe longer until he gets his way. At \$1,100.00 a day times thirty days in that month, the next month, and half of the one before you will have exceeded this amount of money. But when you looked at the fact that school was starting, people were not only terrorizing everybody on that main roadway, but were going through the back roads and disturbing the neighborhoods with excessive speed, people were afraid to back out of their driveways; yeah, our police are very busy now with everything they do and I think they did a very good job for the period of time that they had to police that area.

That money was extremely well spent, and I think as the Solicitor pointed out, once we were put on notice, and we were, okay, the way that you said you wanted to do it, you could abate it by putting up barriers, but you didn't really resolve anything. The real resolve is finishing the road and making it safe again. And I think that says that generally the committee realistically understood that, it was pointed out to us, and I think we acted in an appropriate way. And we're not here to throw away money, we actually believe there will be some healthy resolve to this thing as time goes on and I'm not a dreamer, I just believe there's a lot of municipalities dealing with the same issue, I read in the paper recently that Cumberland County, the Board over there, the Freeholders voted to continue all their projects and there were five of them, so I think there's many more people looking at this in a

similar way, and I think the decision was very well made and in the interest of the residents in that area and the rest of the Township, and the people who drive through there.

Mr. Guishard: I don't want to beat this to death, but the only reason I mention safety is because the safety issue is resolved if the road is closed. You don't have to worry about people speeding and so on and so forth, that resolves the issue. It's inconvenient, and could be costly, but that resolves the issue, so safety is not the issue.

Mayor Silva: You close the whole road with a barrier, right?

Mr. Guishard: We close that portion of the road, yes, just like they've done in many other places in the state.

Mayor Silva: Then what happens with the trucks and all the side roads?

Mr. Guishard: The trucks don't take that road, they go on 54, they take an alternate.

Mayor Silva: That'll never happen. We've been trying to get trucks to go down 54 ever since I can remember here, to cut down on the traffic in the center of town, to alleviate the traffic on 40, to take it off 50, you bring up a point, but I'll tell you what, who's going to follow it? The day we were out there when the road was opening, we were watching the heavy-- right, John? – Tractor trailers going down that road?

Mr. Kurtz: Yes.

Mr. Guishard: Yes, I've been out there.

Mayor Silva: So imagine you, you close the road, Mr. Solicitor? And they run into the barrier.

Solicitor Sandman: That's—that's a different issue. That's a signage issue, I would think. A different issue.

Mr. Guishard: All right, I don't want to---

Mayor Silva: No, I understand what you're doing. You're entitled to it, and I think everybody understood the point that you were making, and I wish we could have gone that way, but once we were put on notice, we either had to abate the situation, or resolve it, and I think we resolved it.

<u>Administrator</u> – none at this time.

 $\underline{Solicitor}$  – Mr. Sandman followed up on Nathan Hall's September  $6^{th}$  discussion of blockage of a paper street; it was determined that the dirt mound in question was on a paper street and was therefore removed.

Mr. Sandman stated that a subcommittee has been developed to address the complaints of the residents living along the river. Last week an informational meeting was held with the owner of Palace Pizza, Mr. Jacobs, Mr. Sartorio, and Chief Tappeiner. The subcommittee will meet again in October to provide proposals to address the issues with trash, noise, etc. It was mentioned that Winding River may be part of the issue as well, so a meeting has been scheduled with Winding River as well. The committee would like to develop a plan that can be implemented in spring.

<u>Engineer</u>- Mr. Filippone reported that a maintenance guarantee inspection was conducted for DDR Hamilton Commons Phase II which resulted in a punch list letter.

Regarding Buffalo Pike, he reported that work is progressing slowly along the Black Horse Pike right-of-way. This has been an issue, as barrels set up for the project are harming the business of Joe's Farm Market. A meeting with NJDOT will take place on 9/20/16 to address and resolve same.

He further stated that internal roadway paving for Holy Cross Cemetery will start on Thursday, 9/22/16 instead of 9/19/16 due to rain.

An inspection of Woods Landing (Fernmoor Homes) stormwater basins resulted in a lengthy punch list letter.

Regarding Linwood Avenue/MUA Project, concrete curbing and two driveway aprons have been installed.

Street openings have slowed down with only one new permit to report.

Mr. Filippone also witnessed soil testing of the stormwater basin at Festival at Hamilton, which showed that a restrictive soil layer of 12" was encountered at the bottom of the basin. Once removed, the basin will remain dry.

Mr. Filippone concluded with a report of a site inspection at Aztec Materials, LLC, resulting in a minor punch list letter.

### Township Committee:

Mr. Kurtz expressed enthusiasm that three new businesses have opened on Main Street, and a nutrition shop will also be coming soon.

He also reminded everyone about the upcoming wine festival on 9/24/16 and 9/25/16. Everything is in high gear, with high advance ticket sales and many great highlights expected, including 14 wineries.

Mr. Guishard seconded Mr. Kurtz' comments regarding the new businesses. He also mentioned that Catering 2/U is another new Main Street business with excellent food and great take-out options.

He also commented that 350 people attended the 9/11 ceremony this year; it was a great ceremony and he extended his appreciation to all involved.

Mr. Laws agreed that the 9/11 event was a very well done and respectful event.

Mr. Laws also spoke briefly about Liepe Football, and mentioned all of the great work that had been done to help the local youth, such as the addition of new goalposts, scoreboard, etc.

Mr. Schenker stated that there was a great deal of talk about Main Street before he took office, and he is excited to see progress in that area.

He also mentioned that Mizpah took second place in a Fire Truck competition at the Firemen's Convention in Wildwood.

Mayor Silva highlighted the success of the 9/11 event, and also mentioned that Movies in the Park had a very good year.

He also mentioned that he recently attended the presentation of a Habitat for Humanity home, and stated that it is great to have the community involved in such projects.

#### Public Comment

<u>Tyrone Russell</u> of Mizpah acknowledged the efforts of Police Chief Tappeiner and hopes more will continue.

Mr. Russell also inquired about the repair of a display that had been damaged. It was agreed that the Administrator and Public Works will look into same.

He further inquired about the Mizpah Center getting some assistance. Some discussion ensued. Mayor Silva suggested that they speak further at Budget time.

Jim Kerrigan of Mays Landing extended congratulations to Amy Gatto.

<u>Carl Pitale</u> of Mays Landing asked about the status of the Lake Lenape Dam Committee. Some discussion ensued. It was agreed that the Administrator will check with Jerry Delrosso, and this item will be placed on a future agenda if there is anything new to report.

Tom and Jamie Schmutz of Malaga Road thanked Committee for their work on Malaga Road.

They expressed continued concern regarding the removal of the dirt mound near their property, and mentioned that they had previously asked for the road to be vacated due to problems with trespassing by hunters and the like. They have small children and are concerned for their safety. Chief Tappeiner discussed the specific ways to post hunting restrictions. Mr. Kurtz stated that the street vacation was before the Planning Board. Mayor Silva asked Mr. Jacobs to look into the issue.

Hearing nothing further from the public, on the motion of Mr. Kurtz, second of Mr. Guishard <u>it was moved to close the public portion.</u>
