

**TOWNSHIP OF HAMILTON
ORDINANCE NO.: 1837-2016**

**AN ORDINANCE AMENDING EXHIBIT A, SECTION 1
ARTICLE II OF CHAPTER 66 OF THE CODE OF THE
TOWNSHIP OF HAMILTON, PROVIDING FOR THE
MAXIMUM NUMBER OF EMPLOYEES**

WHEREAS, the Township Committee has determined that it is in the best interest of the Township to provide a 2% wage increase in 2017 and a 2% wage increase in 2018 to non-aligned employees; and

WHEREAS, certain employees have reached the maximum salary listed for their position; and

WHEREAS, in order to provide the wage increases, certain salary maximums need to be increased; and

WHEREAS, the Electric Sub Code duties will transferred to the current Electrical Inspector; and

WHEREAS, the Fire Official will continue duties related to code enforcement and property maintenance;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Township Committee of the Township of Hamilton, County of Atlantic, State of New Jersey, that Article II of Chapter 66 of the Township Code, titled Personnel, shall be amended as follows:

SECTION 1. Change Salary Maximum

Amend Exhibit A, Section #1 as follows:

SECTION 2. Add new Part-time Regular Dual Position

Amend Staffing Chart and Exhibit A, Section #1, Part-time Regular Dual Positions by adding the following:

Property Maintenance Enforcement Official	\$6,000

SECTION 3. Delete Part-time Regular Dual Position

Amend Staffing Chart and Exhibit A, Section #1, Part-time Dual Positions by deleting the following:

	<u>Salary Maximum</u>
Electrical Sub Code Official/Electrical Inspector	\$15,000

SECTION 4. Severability and Effectiveness Clause.

- (a) If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional, invalid, or unenforceable by a court of

competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

- (b) Any Ordinance inconsistent with the terms of this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION 5. Effective Date.

This Ordinance shall take effect immediately upon final passage and publication as provided by in law.
