ORDINANCE NO.: 1846 -2017

**CAPITAL ORDINANCE PROVIDING FOR THE PURCHASE OF
EMERGENCY EQUIPMENT BY THE TOWNSHIP OF
HAMILTON, IN THE COUNTY OF ATLANTIC, NEW JERSEY,
AND APPROPRIATING \$405,000 THEREFOR**

**BE IT ORDAINED BY THE COMMITTEE OF THE TOWNSHIP OF HAMILTON, IN
THE COUNTY OF ATLANTIC, NEW JERSEY (not less than two-thirds of all the members
thereof affirmatively concurring), AS FOLLOWS:**

SECTION 1.

The improvements described in Section 2 of this ordinance are hereby authorized to be undertaken by the Township of Hamilton in the County of Atlantic, State of New Jersey (the "Township"), as general improvements. For the improvements or purposes described in Section 2, there is hereby appropriated the sum of \$405,000 as required by the Local Bond Law. The total sum is now available by virtue of the existing General Capital Fund.

SECTION 2.

The Township hereby authorize the appropriation of \$405,000 from the Capital Fund for the purpose of purchasing emergency equipment for the Township, including all related costs and expenditures incidental thereto.

SECTION 3.

The improvements described in Section 2 of this ordinance are not current expenses. They are all improvements or purposes that the Township may lawfully undertake as general improvements having a period of usefulness of at least five (5) years, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

SECTION 4.

Any grant moneys received for the purposes described in Section 2 hereof shall be applied to direct payment of the cost of the improvements.

SECTION 5.

The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget will be filed with the Division of Local Government Services.

SECTION 6.

This capital ordinance shall take effect after final passage and publication as required by the law.
