

August 2, 1949

The regular meeting of the Board of Trustees was held at the Municipal Office on August 2, 1949. Present: Mayor C. A. Eccleston, Trustees R. C. Roberts, C. J. Betts, and Dr. J. H. Oates, Supt. R. H. Albrecht and Clerk J. W. Auer. Trustee S. F. Jaquay was absent.

Ralph Bjorkman's Rate

A motion was made by C. J. Betts, seconded by R. C. Roberts and passed that the hourly rate of Ralph Bjorkman be increased from 80¢ to 90¢ per hour effective August 1, 1949 in accordance with Veteran's Administration schedule previously approved.

Sidewalk Allowance

A motion was made by R. C. Roberts, seconded by Dr. J. H. Oates and passed that the Village allowance for new sidewalks constructed be increased effective July 1, 1949 to one-half the cost of construction not to exceed 5 feet in width but not to exceed 20¢ per square foot.

Parking Lot

At the request of the Rotary Club, a motion was made by C. J. Betts, seconded by Dr. J. H. Oates and passed that the Village cooperate with them to again try to get the public to use the parking area on the north side of the playground entrance. The Inn Board says we have permission for its use and Mr. Albrecht said that it only needs mowing to be put to use.

Request for Zoning Change, Lebanon St.

A petition was received by the Board to change an area on the east side of lower Lebanon Street from Industrial to Residential use. It was moved by C. J. Betts, seconded by Dr. J. H. Oates and passed that a public hearing be held on September 5, 1949 between 7:30 and 8:30 P.M. to consider this petition.
