

Police Justice Salary

The Board discussed the duties and salary of the office of Police Justice. A request for a salary increase was made at the last meeting of the Board by Harold H. Evans. At the conclusion of the discussion, it was moved by C. F. Jaquay, seconded by Dr. E. K. Elmer and passed that the salary of the office of Police Justice be increased from \$600 to \$900 per year.

Social Security


Because the State Social Security Agency did not approve the wording of the resolution, the resolution extending Social Security to Village employees was not acted upon at this meeting.
