RESOLUTION NO. ____ - 2020

A Resolution authorizing the City of Harrisburg to use two hundred and fifty thousand dollars (\$250,000.00) of CDBG money to fund the Chutes and Ladders playground project and confirming the City's compliance with applicable laws and regulations.

WHEREAS, the City of Harrisburg receives funding from the Department of Housing and Urban Development (HUD) in the form of, among other things, Community Development Block Grants (CDBG); and

WHEREAS, the City desires to use two hundred fifty thousand dollars (\$250,000.00) of its CDBG award to fund the Chutes and Ladders project through the department of Parks and Facilities and build a playground in accordance with the Reservoir Park Master Site Development Plan. The playground will be built according to green engineering practices and will create a natural play space by using the existing hillsides at the site to mimic the climbing, nets, and ladders features of the classic children's boardgame; and

WHEREAS, funding will only be released to the Department of Parks and Facilities once the Department of Building and Housing Development has received, in writing, sufficient evidence that the expenditures comply with the laws and regulations that govern the CDBG program including 42 U.S.C. § 5301 *et seq.* and all the regulations made pursuant to that statute; and

WHEREAS, the Director of Parks and Facilities, or his designee, shall develop a budget which shall be submitted to the Director of Building and Housing Development, or her designee, and any changes to the budget shall be submitted to the Director of Building and Housing Development for approval, review, and authorization; and

WHEREAS, all requests for reimbursement shall be made within the scope of the budget submitted to the Director of Building and Housing Development, or her designee; and

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that the City of Harrisburg is authorized to use two hundred and fifty thousand dollars (\$250,000.00) of CDBG money to fund the Chutes and Ladders playground project.

BE IT FURTHER RESOLVED that the Mayor, City Controller, and other appropriate City officials are authorized and directed to take all steps necessary to further effectuate the purpose of this Resolution.
