Mayor DelCore advised that in accordance of section 5 of the Open Public Meetings Act, Chapter 231, of the Public Laws of 1975 that notice of this meeting was made by the posting on the bulletin board at the Hillsborough Township Municipal Complex and notifying the officially designated newspapers that this meeting would take place at the Hillsborough Township Municipal Complex at 7:30 p.m. on December 20, 2016.

APPROVAL OF MINUTES

• Approval of the December 13, 2016 Regular Session Meeting Minutes

Upon a motion by Committeeman Burchette, seconded by Deputy Mayor Suraci, the minutes of the December 13, 2016 Regular Session were approved upon the call of the roll.

REPORTS FROM COMMITTEE LIAISONS, AND RECEIPT OR REPORTS, PETITIONS OR COMMUNICATIONS

Committeeman Burchette

Committeeman Burchette reported that the Building Department will be closed the evening of Tuesday, December 27th.

Committeewoman McCauley

Committeewoman McCauley stated that in an effort to consolidate resources, Hillsborough is transitioning to Swift Reach 911 for emergency notifications. Committeewoman McCauley said this move will eliminate reduce duplication of services between Honeywell and Nixle, as those services will be suspended effective 12/31/16. Committeewoman McCauley noted that Swift Reach is a high speed emergency notification system that alerts residents to emergency situations including weather and traffic related issues.

Committeewoman McCauley added that residents will be urged to update their information, contact preferences and any additional phone numbers and email addresses. Committeewoman McCauley said that more information will be forth coming on registration.

Committeewoman McCauley reminded residents that there will not be any Municipal Court Sessions on Monday, December 26th, Tuesday, December 27th and Monday, January 2nd.

Committeewoman McCauley noted that nominations for the 2017 Outstanding Women in Somerset County awards program, sponsored by the Somerset County Commission on the Status of Women are due.

Deputy Mayor Suraci

Deputy Mayor Suraci said that the Finance Department will begin mailing 2017 dog license renewals to all residents who licensed their pet in 2016 the week of January 2nd, 2017. Deputy Mayor Suraci stated in order to renew, your dog must have a rabies vaccination on file that is valid through October 2017. Deputy Mayor Suraci added that the Township's free online payment system for licensing your pet will be available for renewals after January 2nd, at www.hillsborough-nj.org.

Deputy Mayor Suraci reminded residents that they can obtain a Hillsborough Rewards Credit Card through the local Affinity Federal Credit Union branch. Deputy Mayor Suraci added that this credit card is unique because not only do you as the card holder earn rewards, a percentage of the usage on the card is used to fund the Credit Card Grants that are issued twice a year to Township based youth, senior and non-profit organizations.

Committeeman Tomson

Mayor DelCore reported that Committeeman Tomson left a report for Committeeman Burchette to read.

Committeeman Burchette stated that there are some new Recreation Programs For Winter: Basketball Squirts is a Co-Ed Basketball Skills Program for Kindergarteners. Committeeman Burchette noted that this class introduces your child to the fun and exciting sport of basketball. Committeeman Burchette added that players will be taught through a series of fun challenges, structured activities and scrimmages.

Committeeman Burchette said that there is a Smartphone Photography class for youth and adults to explore the art of photography using your smartphone cameras. Committeeman Burchette added that each week, there will be a discussion and review of famous photos, learn about lighting, camera operation and controls, and apply the skills during our weekly photo shoots. Committeeman Burchette noted that at the final class, students can invite their friends and family to the Photo Gallery event!

Committeeman Burchette stated that registration for these and all winter recreation programs is available on the Parks & Recreation website.

Committeeman Burchette informed residents that there will be a Free Rabies clinic for Cats and Dogs on Saturday, January 14th at the Hillsborough Department of Public Works, located at 21 East Mountain Road. Committeeman Burchette added that the clinic will run from 10 am until noon and there is no registration necessary. Committeeman Burchette noted to please be sure to check the website before coming out to ensure that the clinic will be taking place.

Committeeman Burchette stated that the Somerset County Library System announced that starting in 2017, the following branches will be open on Sunday's year round: Bridgewater, Hillsborough and Warren Township. Committeeman Burchette said to please visit the Library's website for any additional information.

Mayor DelCore

Mayor DelCore thanked his colleagues and Township residents for the honor of serving as Mayor for 2016. Mayor DelCore recapped some of the highlights of the past year including, the record snowfall from winter storm Jonas, the warehouse fire in February, keeping the Municipal Budget under the 2% Cap, no change to our tax rate, rebuilding Castle Park, the express bus service from Hillsborough to New York City as well as many awards throughout the year. Mayor DelCore said that as additional information becomes available and once we have the date and other specifics from NJDOT regarding the informational session, we will be sure to provide that information so those interested residents will be aware.

Mayor DelCore noted that the 2017 Township Reorganization Meeting will be held on Tuesday, January 3rd at 7 pm here in the Court Room.

WHEREAS, there exists a vacancy in the Hillsborough Township Police Department for the full-time position of Police Records Clerk; and

WHEREAS, the Chief of Police recommends the hiring of Sue Capolongo to the position of Police Records Clerk, effective December 27, 2016, at a salary of \$32,323.20 per year.

3. RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) REPLACEMENT MARKED POLICE VEHICLES AND ONE (1) PICKUP TRUCK FROM BEYER FORD, AT AN AMOUNT NOT TO EXCEED \$97,000.00, THROUGH THE CRANFORD POLICE COOPERATIVE PRICING SYSTEM

WHEREAS, Hillsborough's Police Chief has recommended the continuation of the Township's vehicle replacement program, through the replacement of two marked police vehicles and one pickup truck in order to maximize effectiveness of the Patrol Division for the protection of the community; and

WHEREAS, the Police Chief further recommends the three vehicles be purchased from Beyer Ford, at a total cost of \$70,000.00 for two (2) Ford Police Interceptor Sedans and \$27,000.00 for one (1) Ford pick-up through the Cranford Police Cooperative Pricing System (Contract #47-CPCPS); and

WHEREAS, the replaced marked vehicles will be used to replace three (3) aging administrative vehicles in the fleet and these aging administrative vehicles will be turned over to the Director of Public Works or placed on auction by the Township; and

WHEREAS, the Township of Hillsborough is a member of the Cranford Cooperative Pricing System which, under the authority of N.J.S.A. 40A:11-10, seeks competitive bids for police vehicles on behalf of member municipalities; and

WHEREAS, \$54,000.00 of the \$97,000.00 for this purchase is coming from the 2016 Safe Corridors Grant and the remaining \$43,000.00 will be funded through the 2016 Municipal Budget; and

WHEREAS, these funds are available and have been certified as such by the Chief Finance Officer said certification is attached to this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that it hereby authorizes and approves the purchase of two (2) replacement marked police vehicles and one (1) pickup from Beyer Ford, at a cost not to exceed \$97,000.00, through the Cranford Cooperative Pricing System (Contract #47-CPCPS)

Mayor DelCore said that the purchase of these vehicles continues the Police vehicle replacement program that is run each year.

Deputy Mayor Suraci noted that new police cars aren't purchased each year just to purchase them. Deputy Mayor Suraci stated that this is to replace broken down cars in order to keep our fleet running smooth.

Upon motion by Committeeman Burchette, seconded by Committeeman Tomson, the aforesaid resolution was unanimously approved upon call of the role.

4. RESOLUTION APPROVING AGREEMENT BETWEEN THE TOWNSHIP OF HILLSBOROUGH AND THE SOMERSET COUNTY YMCA-HILLSBOROUGH BRANCH FOR THE HILLSBOROUGH SENIOR CITIZEN EXERCISE WELLNESS PROGRAM

WHEREAS, over the years the Township provided an exercise wellness program for Hillsborough senior citizens consisting of exercise classes at the Municipal Building; and

WHEREAS, in 2014 the Township and the Somerset County YMCA - Hillsborough Branch ("YMCA") entered into an agreement to provide a more comprehensive exercise wellness program through the YMCA for the benefit of Hillsborough senior citizens; and

WHEREAS, due to the success of the exercise wellness program the Township and YMCA seek to renew the program for 2017 upon the terms and conditions set forth in the Agreement attached hereto in an amount not to exceed \$21,700.00; and

WHEREAS, the Chief Finance Officer of the Township has certified that sufficient funds are available for this Agreement as set forth in the certification attached hereto.

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that the attached Agreement between the Township of Hillsborough and the Somerset County YMCA – Hillsborough Branch for the Hillsborough Senior Citizen Exercise Wellness Program is hereby approved and the Mayor and the Township Clerk are authorized to execute the Agreement.

Mayor DelCore noted that this resolution renews the agreement with the YMCA to provide exercise services and supplemental benefits through the Senior Exercise Program. Mayor DelCore added that our senior community is a very important and vital part of our Township and it is important to renew this agreement to maintain this well attended program.

Upon motion by Committeewoman McCauley, seconded by Committeeman Tomson, the aforesaid resolution was unanimously approved upon call of the role.

5. RESOLUTION AUTHORIZING THE AWARD OF A THREE (3) YEAR CONTRACT TO ST. HUBERT'S GIRALDA FOR ANIMAL CONTROL SERVICES IN AN AMOUNT NOT TO EXCEED \$103,885.20 PER YEAR EFFECTIVE JANUARY 1, 2017

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-4.1(r), the Township Committee adopted a resolution authorizing the Township Qualified Purchasing Agent to use the competitive contracting process for the procurement of animal control services for the Township of Hillsborough; and

WHEREAS, pursuant to N.J.S.A. 40A:4-5, the Qualified Purchasing Agent evaluated the proposals received in accordance with the methodology described in the request for proposals and has submitted such evaluation and recommendation to the Township Committee for consideration; and

WHEREAS, the Qualified Purchasing Agent indicates that St. Hubert's Giralda was the only entity to submit a valid response to the request for proposals; and

WHEREAS, the Qualified Purchasing Agent recommends a three (3) year contract be awarded to St. Hubert's Giralda for the provision of animal control services for the Township of Hillsborough in an amount not to exceed \$103,885.20 per year for the period January 1, 2017 to December 31, 2019; and

WHEREAS, funds shall be made available for said contract as certified by the Chief Finance Officer, said certification is attached to this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, the Mayor and Township Clerk are hereby authorized to execute a contract with St. Hubert's Giralda for a three (3) year contract for Animal Control Services in an amount not to exceed \$103,885.20 per year for the period January 1, 2017 to December 31, 2019.

Mayor DelCore stated that St. Hubert's has provided dog catcher and dog pound services for the Township for many years. Mayor DelCore added that this resolution authorizes an agreement for the next three years, resulting in a cost savings of nearly \$67,000 over the course of the 3 year contract. Mayor DelCore noted that for the Township to hire personnel and construct a holding facility and operate such a program, the cost would be far beyond the costs in the St. Hubert's proposal.

Upon motion by Committeewoman McCauley, seconded by Deputy Mayor Suraci, the aforesaid resolution was unanimously approved upon call of the role.

6. RESOLUTION AUTHORIZING CME ASSOCIATES TO PROVIDE ADDITIONAL SITE INVESTIGATION SERVICES FOR BLOCK 86, LOT 21 AND BLOCK 90, LOT 6.01 AS THEY RELATE TO THE TOWNSHIP'S AFFORDABLE HOUSING PLAN, AND IN ACCORDANCE WITH THE TECHNICAL REQUIREMENTS FOR SITE REMEDIATION (N.J.A.C. 7:26E) IN A TOTAL AMOUNT NOT TO EXCEED \$41,360.00

WHEREAS, the Township is in need of additional site investigation services for Block 86, Lot 21 and Block 90, Lot 6.01, as they relate to the Township's Affordable Housing Plan and in accordance with the Technical Requirements for Site Remediation (N.J.A.C. 7:26E); and
