Ms. Borek then read the following Notice of Meeting: in accordance with Section 5 of the Open Public Meetings Act, Chapter 231, Public Laws of 1975, that notice of this meeting was made by the posting on the bulletin board at the Hillsborough Township Municipal Complex and notifying the officially designated newspapers that this meeting would take place at the Hillsborough Township Municipal Complex at 7:00 p.m. on January 2, 2018.

Ms. Borek acknowledged some of the honored guests in the room: Congressman Leonard Lance, Senator Kip Bateman, Assemblyman Jack Ciattarelli, Assemblyman Andrew Zwicker, Assemblyman-elect Roy Freiman, Freeholder Brian Levine, Freeholder Mark Caliguire, Mayor Bob Wagner, Deputy Mayor Helen Haines, Mayor and Township Administrator Anthony Ferrera, Mrs. Joan Biondi and Township Administrator Kevin Davis.

Ms. Borek read the Certification of Election Results; Somerset County Clerk Brett Radi has certified the results of the November 7, 2017 Election, re-electing Gloria McCauley and Doug Tomson to the Hillsborough Township Committee for a three-year term beginning January 1, 2018 and ending December 31, 2020.

OATHS OF OFFICE TO ELECTED COMMITTEE MEMBERS

Ms. Borek announced that Honorable Senator Kip Bateman would issue the Oath of Office to re-elected Committeewoman Gloria McCauley.

Honorable Kip Bateman, Senator, administered the oath to Committeewoman McCauley.

Ms Borek announced that Honorable Assemblyman Jack Ciattarelli would issue the Oath of Office to re-elected Committeeman Doug Tomson.

Honorable Jack Ciattarelli, Assemblyman administered the oath to Committeeman Tomson who was accompanied by his wife and daughters.

Roll call was taken again with all elected Committee members present.

ELECTION OF 2018 Mayor

Ms. Borek opened the floor for nominations for the 2018 Mayor of Hillsborough Township. A motion was made by Committeeman Suraci and seconded by Committeeman Tomson to elect Gloria McCauley as the 2018 Mayor of the Township of Hillsborough.

Mayor McCauley stated that at this time she would like to continue the tradition of recognizing the outgoing Mayor by presenting Committeeman Suraci with a gavel set and an additional gift from the Township Committee.

COMMENTS BY THE Mayor

Mayor McCauley began by wishing a good evening and Happy New year to everyone in attendance.

Mayor McCauley thanked his colleagues on the Township Committee for electing her to serve as Mayor for 2018. Mayor McCauley congratulated Deputy Mayor Tomson on being selected as Deputy Mayor and on his victorious re-election this past fall.

Mayor McCauley thanked her family and friends for their continued support that allows her this opportunity to serve her community. Mayor McCauley thanked the Republican Organization for their continued support of the members here on the dais.

Mayor McCauley thanked all of the State and County officials who came out tonight. Mayor McCauley thanked Reverend Wolf for his invocation as well as Girl Scout Service Unit 72 along with Captain Boyle for presenting the colors and leading us in the Pledge of Allegiance.

Mayor McCauley also acknowledged the collective work of all the Municipal employees in providing exceptional customer service for the residents of Hillsborough which has helped the Hillsborough continue to receive so much recognition over the years, most notably being named to Money Magazine's Best Places to Live in America multiple times. Mayor McCauley also thanked all the dedicated volunteers who give their time and talents for the benefit of the Township.

Mayor McCauley thanked her family and closest friends who support her, keep her focused and give her strength. Mayor McCauley also thanked the voters of Hillsborough for their trust and support stating its an honor to serve.

Mayor McCauley stated in 2017 Mountainview Park was officially opened along with the Somerset County Freeholders, quiet zones were recertified, park improvement program continued with the renovation of the Skate Park and electronic scoreboards at AVM park. The Hillsborough Township Police Department received the NJ State Accreditation for the 3rd consecutive time, one of only 8 departments in Somerset County. The Township's website was reconfigured for improved user experience, the Office of Emergency Management is on Facebook, Swift Reach 911 became the notification system and a guest wifi network was opened at the municipal building for residents and visitors.

Mayor McCauley said that the Township Committee has maintained a watchful eye on fiscal operations by maintaining a budget within the 2% cap for 7 consecutive years since the cap was instituted, never taking

advantage of loopholes to exceed the cap, fiscal prudence will remain a top priority of this Township Committee.

There will be continued collaboration with sustainability partners on the progress of the trail system around the municipal complex and continued monitoring of affordable housing requirements.

BE IT FURTHER RESOLVED in any case where the taxes are not paid during the respective extended periods, the full interest rate from the due date shall apply.

4. RESOLUTION AUTHORIZING TAX SALE RELIEF

WHEREAS, the governing body of the Township of Hillsborough, County of Somerset, State of New Jersey wants to grant taxpayers with personal hardships relief from the tax sale; and
