2018-05 Ordinance of the Township of Hillsborough, Somerset County, New Jersey, amending Chapter 188 “Land Use And Development”, Article V “Districts And Standards”, Section 188-113.5 “TC Town Center District” of the Code of the Township Of Hillsborough. *Further consideration of this ordinance and public hearing will be held on May 22, 2018.*
