

TOWNSHIP OF KNOWLTON
WARREN COUNTY, NEW JERSEY

July 11, 2016

The monthly meeting of the Knowlton Township Committee was held on this date at the Municipal Building, 628 Route 94, Columbia, New Jersey. This meeting was called to order at 7:02 p.m. by Mayor Adele Starrs.

The Mayor read the following statement in compliance with the "Open Public Meetings Act". In accordance with Chapter 231 of the Public Laws of 1975, notice of this meeting was given by way of publication with the Star Gazette and/or the Express-Times, filed in the Municipal Clerk's Office and posted in the Knowlton Municipal Building.

Mayor Starrs led the public in the pledge of allegiance.

These bills will be further reviewed and were removed for approval. Mayor Starrs would also like to see a purchase of a wood chipper for next year.

Executive Session:

Motion was made by Mayor Starrs, Seconded by Committeewoman Cuntala and carried to come out of Closed Session at 7:43 and return to Regular Session.

Public Comment:

Donna Connelly and Chuck Connelly voiced their concerns for the safety of their daughter who is going into the 7th grade. Her bus stop has no lighting, sidewalks and no place for a child to stand. The bus comes at 6:45 when it is still dark. The Connellys have called the school board of education and no one helped them. Mayor Starrs said that the committee can try to help but the Board of Education is not under the Committee's jurisdiction and is responsible for bussing. Committeewomen Shipps offered to call North Warren of behalf of the committee.

Mr. VanHorn made comment regarding minutes from 2011. He stated that he does not remember passing the minutes. Mayor Starrs explained that she has proof that the minutes were passed and that it will be up for discussion later in the meeting. Mayor Starrs had said that the minutes were on the agenda for the past three meetings.

David Neil, EMS captain, was invited by Committeeman Mathez to give an update on the EMS coverage transition. An email from Rodney Woolf, Monroe County Operation Supervisor, was read to the public. It stated there was a successful start and 5 out of 8 full time employees necessary for the operation were hired. They also hired 2 per diem staff members and are continuing with the hiring process. They have hired qualified EMTs with knowledge of routes in Warren County and are continuing to interview for the remaining position. David Neil personally would like to thank the Committee for their help and guidance and is very happy to be working with the township. EMTs have been driving around to familiarize themselves with the area. So far everything has gone very smoothly and there is open communication with Rodney Woolf. Mayor Starrs asked if any Knowlton residents were hired. There are 2 from Phillipsburg 1 from Oxford, none from local township but there are 4 full time slots left. David did not know who has applied for the positions.

ORDINANCE #2016-09

ORDINANCE AUTHORIZING THE SALE FOR NOMINAL CONSIDERATION OF AN AMBULANCE TO THE KNOWLTON FIRE AND RESCUE

WHEREAS, the Township of Knowlton purchased a 1996 ambulance, Ford Van VIN #1FDKE 30F3T HBB309 54 ("Ambulance") for use by Knowlton Fire and Rescue; and

WHEREAS, the Ambulance has reached the end of its useful life and needs to be replaced; and

WHEREAS, the Township of Knowlton has determined that the Ambulance is no longer needed for municipal purposes; and

WHEREAS, Knowlton Fire and Rescue has agreed to accept the donation of the title to the Ambulance and will use the proceeds from any sale of the Ambulance for fire and rescue purposes; and

WHEREAS, N.J.S.A. 40A:12-21 authorizes a governing body by Ordinance to sell for nominal consideration to certain organizations unneeded personal property without compliance with other laws governing the disposal of personal property by municipalities; and

WHEREAS, Knowlton Fire and Rescue is a type of organization to which unneeded personal property may be sold for a nominal consideration

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Knowlton, County of Warren, State of New Jersey, as follows:

1. It is hereby authorized that the Ambulance will be sold to Knowlton Fire and Rescue for \$1.00.
2. The Ambulance shall be used by Knowlton Fire and Rescue only for volunteer fire and rescue services, or may be sold as appropriate, but may not be used for commercial business, trade or manufacture, and if the Ambulance, or the proceeds from the sale thereof, are not used in accordance with the limitations set forth herein, ownership of the Ambulance, or the proceeds from the sale thereof, shall revert back to the Township of Knowlton.

Salt Update

Mayor Starrs reported that the DEP conducted a second round of townwide testing for salt in well water. The Township Building is still high. The other 28 wells did not change. There has not been a huge seasonal difference from when they first tested prior to the winter and this spring. A letter from the DEP stated that it was premature to give a preliminary conclusions. NJDEP senior staff are meeting next to review the results to determine recommendations to make for Knowlton.

Winter Maintenance

Mayor Starrs, Committeeman Mathez and Ted Rodman met with DOT and Joint Toll Bridge Commission and Warren County to talk about winter maintenance. DOT is willing to make the winter maintenance that we did this past winter permanent with a contract. The Committee will wait on the report from the DEP before making a final decision on this contract.

Columbia Townwide Roadside Trimming

Mayor Starrs reported that a number of complaints have been received regarding roadside trimming. Motion was made by Committeeman Mathez seconded by Mayor Starrs to have the road department make the roadside trimming a high priority.

Committeewoman Shippis has been calling around to get quotes on getting new cell service. Also questioned if the Road Dept. needs smartphones. Supervisor is the only one who uses a smartphone. Does not matter what cell phone provider we use, just go with the best deal.

150 Vail Road

Committeewoman Shippis is proceeding in talking with heirs to get on the property and demo it.

Gypsy Moth

Committeeman Farber mentioned that we did get paid from the state. Gypsy moth spraying cost-roughly \$10,000.00 and we have been reimbursed by the state for roughly \$2,900.00.

Recreation Center/Knowlton Field

Committeewoman Shippo was approached by the Anderson family, who thinks that we have done a fantastic job, their only complaint is that the bathrooms are always closed unless there is someone there to open.

Speeding on Washington St.

Committeeman Mathez brought up speeding in the village of Columbia. Motion was made by Committeeman Mathez and seconded by Mayor Starrs to write a letter to the DOT asking for stop signs and paint to reinforce stop signs.
