AN ORDINANCE OF THE BOROUGH OF LAVALLETTE, IN THE COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 20 OF THE CODE OF THE BOROUGH OF LAVALLETTE TO AMEND VARIOUS FEES CHARGED

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Lavallette, in the County of Ocean, State of New Jersey, as follows:

SECTION 8. § 20 of the Code of the Borough of Lavallette, entitled "Construction Codes, Uniform" is hereby amended and supplemented to revise the fees charged in connection with the issuance of a construction permit. Section § 20-3A shall read in its entirety as follows:

§ 20-3. Fees.

(5) Fees applicable to Subsections A(1) through (4) above.

(a) Plan review fee: 20% of the amount to be charged for a new construction permit. In addition, there will be a fee of \$65.00 per hour with a minimum of one hour

(6) Temporary certificate of occupancy: \$60 (~~no fee when CO fee paid in full at the time of the initial issuance of the TCO~~).

(6) Change in Contractor for any disciplines during the course of work being performed:
\$65.00


