AN ORDINANCE

"SENIORS ADVISORY COMMITTEE"

*"Interpretive Statement"*

*This ordinance will add a member of the Maplewood Memorial Library Board as an ex officio nonvoting member of the Maplewood Seniors Advisory Committee.*

WHEREAS, the Township of Maplewood Seniors Advisory Committee ("Seniors Advisor Committee") has requested a member of the Maplewood Memorial Library Board be added as a member of the Seniors Advisor Committee; and

WHEREAS, the Maplewood Township Committee agrees that having a member of the Maplewood Memorial Library Board as a member of the Seniors Advisory Committee, would be beneficial to the seniors of the Township of Maplewood.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey Chapter 59 of the Code of the Township of Maplewood entitled "Seniors Advisory Committee" shall be amended as follows.

**FIRST:** Chapter 59 Seniors Advisory Committee  
Shall be amended as follows:

**Section 59-4 Membership; Term of Office**

The Township Committee shall appoint eleven (11) residents of the Township, at least six (6) of whom shall be Seniors and one of whom shall be under the age of 25, to serve as Members of the Maplewood Seniors Advisory Committee.

A. Term.

(1) The initial appointments shall be designated as follows:

(a) Four (4) shall be appointed for (3) three-year terms.

- (b) Four (4) shall be appointed for (2) two-year terms.
- (c) Three (3) shall be appointed for (1) one-year terms.

(2) Thereafter all reappointments shall be for a term of three (3) years. All terms shall expire December 31 of the last year of the appointee's term.

- B. In addition to the appointed members, the Director of Recreation and Cultural Affairs, the Health Officer, the Zoning Official, the Welfare Director for the Township of Maplewood, and a member of the Maplewood Memorial Library Board shall serve on the Maplewood Seniors Advisory Committee as (ex officio) non-voting members.
- C. A member of the Maplewood Township Committee shall serve as a liaison to the Maplewood Seniors Advisory Committee and shall be non-voting.
- D. The Maplewood Seniors Advisory Committee shall select a chair from amongst its members.

**All other Sections shall remain unchanged.**

**SECOND: Severability:**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**THIRD: Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**FOURTH: Effective Date**

This Ordinance shall take effect after final passage and publication and as provided by law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title at a meeting of the Township Committee of the Township of Maplewood, held on January 16, 2018, and that the Township Committee met again on February 6, 2018, at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Township Committee held a hearing and proceeded to consider the said Ordinance on final reading and final passage.
