**AN ORDINANCE
TO AMEND
CHAPTER 123
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD
ENTITLED
"FEES"
(Municipal Pool)**

"Interpretive Statement"

This ordinance will revise pool rates beginning in 2018 and will add a Non-Resident Membership.

WHEREAS, the Maplewood Swimming Pool Advisory Committee (the "Committee") voted to recommend the elimination of the College Student Category and to add a Weekend Only (Saturday and Sunday) Category; and

WHEREAS, the Maplewood Township Committee determined to follow the recommendation of the Committee.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 123 of Code of the Township of Maplewood entitled "Fees" be amended to change the usage fees for the Maplewood Municipal Pool as follows:

FIRST: Chapter 193 Parks and Recreation Areas

A. Article II, Maplewood Community Pool.

(1) Schedule of Fees shall be amended to read as follows:

SECOND: Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

THIRD: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: Effective Date

¹Couple category consists of either two (2) cohabitating adults or an adult and child under the age of eighteen (18) .

²Family categories are made up of two (2) adults and their custodial children.

³Family and Caregiver is made up of two (2) adults, one (1) caregiver and custodial children.

This Ordinance shall take effect after final passage and publication and as provided by law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on February 20, 2018 and that Committee met again on March 6, 2018, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
