- If you answer “**No**” to a numbered question, move on to the next numbered question.
- Check appropriate column to indicate the anticipated size of the impact.
- Proposed projects that would exceed a numeric threshold contained in a question should result in the reviewing agency checking the box “Moderate to large impact may occur.”
- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.

REASONS SUPPORTING DETERMINATION  
February 5, 2019**

The Town of New Castle Planning Board is Lead Agency for the review of an application from the Chappaqua Central School District, for preliminary subdivision approval, steep slopes and tree removal permits, as well as a stormwater pollution prevention plan approval for a 6-lot subdivision of an existing 20.3 Acre property located between Buttonhook Road and Sabina Road. Six single-family lots consisting of 2+ Acres are to be created and served by subsurface sanitary sewer disposal systems and public water. A 1,242 Linear Foot roadway is proposed to access the lots. The proposed lots will be developed with 4-bedroom homes, pools, patios, cabanas, and parking court yards. The 20.3 Acre property is known as Tax Map #81.12-1-8.

The property is currently located in a two Acre Single-Family Residential Zoning District (R-2A). The property is surrounded by one Acre single family homes to the east (R-1A Zoning District) and two Acre single family properties to the north and south. There is a large single-family property located in the two-Acre zone adjacent to the western boundary. The project is located within the New York City Watershed.

Based upon a review of Parts 1 and 2 of the Full Environmental Assessment Form, all other application materials that were prepared and subsequently reviewed for this action, memoranda from Town staff and consultants, public comment, observations from a site visit conducted on April 2, 2016, and testimony from meetings held on February 17, 2015, April 21, 2015, June 17, 2015, September 16, 2015, May 17, 2016, July 19, 2016, September 20, 2016, October 2, 2018 and December 4, 2018 the Town of New Castle Planning Board hereby makes a determination of significance as follows: The Proposed Action will not have a significant adverse environmental impact on land, surface water, groundwater, plants and animals, historic and archeological resources, aesthetic resources, transportation, public health and safety, noise, odor, light or air, community character, nor any other relevant area of environmental concern.

Impact on Land and Water

The Proposed Action includes the following:

- Six single-family lots consisting of 2+ Acres are to be created and served by subsurface sanitary sewer disposal systems and public water.
- A 1,242 Linear Foot roadway is proposed to access the lots.
- The proposed lots will be developed with 4-bedroom homes, pools, patios, cabanas, and parking court yards.
- The total amount of disturbance to develop the site is 11.13 Acres.

- 4,011 SF of the disturbance is to be temporary to install the stormwater discharge level spreaders (part of the stormwater management systems).
- 2.68 Acres of impervious area will be created as a result of the proposed development.
- Disturbance to 43,842 Square Feet of steeply sloped land.

The proposed subdivision has been carefully designed to maximize the area of protected open space within the subdivision. Each of the six lots have been designed in such a way that there are large areas of protected open space between each of the proposed building envelopes. This area, when added to the proposed protected open space lot (which includes stormwater management facilities) will result in approximately 9.5 Acres of land as designated protected open space, referred to as the Protected Buffer Area. The Protected Buffer Area will be demarcated with concrete monuments that will be installed flush to the ground. A metal tag will be secured to the top of the monument with the label "Protected Buffer Area".

The Proposed Action includes implementation of a stormwater management plan which includes standard stormwater management practices with runoff reduction capacities (infiltration practices) and standard stormwater management practices (underground storage vaults and a detention basin) for the treatment of the increased runoff that will be caused by the proposed development. Pre-treatment units (sand filter and Vortechs unit) have also been incorporated into the project. Utilization of the stormwater practices have shown that there is a reduction of the post-development peak runoff rates to below pre-development peak runoff rates. The stormwater management plan also includes the use of catch basin sumps, pre-treatment practices, and overflow spreaders to improve the quality of the runoff flowing from the proposed area of development and to minimize the conveyance of sediment as specified in the "Engineer's Report Stormwater Runoff Evaluation" dated May 2018 and last revised January 2019 and reviewed by the New Castle Town Engineer. Implementation of the stormwater management plan will result in no net increase in stormwater runoff from the developed site as compared to pre-development conditions.

The Proposed Action includes connection of the property to a public water system and therefore no groundwater wells will be constructed. An 8" water main will be offered for dedication to the Town of New Castle, along with easement for extension off of Sabina Road.

Wastewater disposal will occur on each lot in Westchester County Health Department-approved subsurface wastewater disposal systems.

There are no wetlands or wetland buffers on the subject property.

The proposed subdivision will disturb approximately 11.2 AC of area. The disturbance includes 1.19 Acres of moderately steep slopes (15-25%), 0.34 AC of very steep slopes (25-25%) and 0.15 AC of extremely steep slopes (>35%). Erosion control measures will

be utilized during the disturbance of the sloped land. These measures include silt fencing, hay bales, temporary sediment basins and diversion swales and immediate seeding and mulching. Additional details and information regarding the erosion and sediment controls has been submitted by the applicant and included in the Erosion and Sediment Control Plan which is consistent with the NYSDEC standards.

The Applicant will provide an Erosion and Sediment Control Plan consistent with the NYSDEC standards as part of the final subdivision approval. This plan has been reviewed and approved by the New Castle Town Engineer.

Accordingly, the Proposed Action will not result in any significant adverse environmental impacts on land or on surface or groundwater quality or quantity.

#### Impact on Plants and Animals

The Proposed Action will require the removal of 676 on-site trees, of which 471 trees are subject to replacement. The Applicant has demonstrated that they are able to meet the replacement requirement of 607 trees on-site as per the Town's Tree Preservation Law. In accordance with Chapter 121, the Applicant's mitigation plan includes a combination of 50% larger canopy replacement trees, 25% smaller understory trees and 25% shrubs to replace trees that will be removed as part of the project. The New Castle Environmental Coordinator has confirmed compliance with the Town's Tree Preservation Law and the mitigation requirements.

As part of the project, approximately 2+ Acres of open space that resulted from the final layout of the septic systems and stormwater management systems would be lost. The Applicant has agreed to offset the loss of open space through establishing a "Protected Buffer Area" consisting of the naturally treed areas between each of the lots, the area of the location of the stormwater management practices, as well as additional areas to the rear of each of the proposed lots. In total, approximately 9.5 acres of land will be designated as "Protected Buffer Area". The "Protected Buffer Area" will be demarcated using flush to the ground monuments with metal tags.

There is no proposed impact to unique or rare habitats or species of mammals, birds, amphibians, reptiles or fish to the extent any such species are present on or near the site as per documentation submitted by the Applicant from the State Department of Environmental Conservation on October 25, 2016.

Accordingly, the Proposed Action will not have a significant adverse environmental impact on any threatened or endangered animals or plants as confirmed by the State Department of Environmental Conservation on October 25, 2016.

### Impact on Historic and Archeological Resources

The project site does not contain areas designated as sensitive for archaeological sites on the NY State Historic Preservation Office (SHPO) archaeological site inventory. The Proposed Action will not have a significant adverse environmental impact on historic and archeological resources.

### Impact on Aesthetic Resources

The overall layout of the proposed subdivision has been considerate of topography. During the review of the subdivision layout, the homes were relocated away from the high points on the site to lower elevations on each of the lots, as was practical. This shift preserved more existing mature trees at the higher site elevations, thereby retaining more of a tree canopy at the higher elevations. As such, the homes have been nested into the adjacent wooded areas which provide a more natural viewshed into the property. This approach was also dictated by the maximization of protected open space, whereby limitations on the building envelope and protected planting between the proposed homes enhance the overall aesthetic of the subdivision.

Accordingly, the Proposed Action will not create a significant adverse environmental impact on aesthetic resources.

### Impact on Transportation

The six lot subdivision will generate traffic associated with a typical subdivision. In accordance with the New Castle Town Code requirements, each dwelling is required to have two parking spaces. Approximately 12 + cars will be added to the area roadways which is a nominal addition of traffic. Each of the proposed lots will be accessed by way of an extension of Button Hook Road. This 1,242 Linear Foot roadway terminates in a cul-de-sac and is required per the Town Code and the Town Engineer to be constructed to meet Town roadway specifications so that it can be offered by dedication to the Town.

As such, the Proposed Action will not result in a significant increase in traffic volume above the levels associated with its use and it will not generate new demand for transportation facilities or services that would not be otherwise anticipated. As such, the Proposed Action will not have a significant adverse environmental impact on existing transportation systems.

### Impact on Public Health and Safety

The proposed subdivision will include development of a new roadway, stormwater management systems and clearly defined protected space. All buildings will be constructed in accordance with State and Local fire and building standards. The plans and materials submitted by the Applicant indicate that there is appropriate access for emergency vehicles on site.



The Westchester County Health Department is the regulatory agencies who is responsible for the individual subsurface wastewater disposal systems. These systems have been designed in accordance with those standards.

As such, the Proposed Action will not have a significant adverse environmental impact on public health and safety.

#### Impact on Noise, Odor, Light and Air

- The Proposed Action involves locating outdoor lighting which reflects typical lighting for residential purposes. No glare or light spillage will occur onto adjacent properties.
- Except for the limited time period of construction, noise will be to the extent which is expected of residential uses.
- Except for the limited time period of construction, air quality will not be compromised.

Per the project information the Proposed Action will not have a significant adverse environmental impact on noise, odor light or air quality.

#### Consistency with Community Plans and Community Character

- The proposed use is consistent with the Comprehensive Plan in that the property is located in an R-2A (Residential Single Family) Zoning District and the proposed use is permitted in that District and the individual lots, roadways, septic areas, water lines conform to all zoning requirements.

The impacts as enumerated herein have been carefully examined by the Town of New Castle Planning Board and professional staff. There are no potential significant adverse environmental impacts related to the proposed project.
