BE IT THEREFORE RESOLVED to adopt Local Law #1 of 2018 to Amend Chapter 46 (Keeping of Animals) in the Village Code of North Collins. Motion made by Trustee Melvin Bley seconded by Trustee Karen Denne to adopt said resolution. Unanimously Carried.

Proposed Local Law to Amend Definitional Sections in Chapter 103 (Housing Standards), Section 103-47(B) defining the terms “Camp, Cottage or Cabin”, and Section 103-7 “Dwelling, One-Family” of the Village Code.

Proof of Publication received in form of affidavit from Dunkirk Observer; Legal Notice in June 23rd issue of Dunkirk Observer—paper mistakenly eliminated date of hearing so reposted in June 29th issue of Dunkirk Observer at no cost.

Update specifies minimum size of a one-family dwelling and a camp cottage or cabin.
