ORDINANCE NO. 1372-20

AN ORDINANCE OF THE CITY OF PARK HILLS, MISSOURI, REPEALING CHAPTER 700, SECTION 700.030, SECTION C AND REPLACING A NEW SUBSECTION C AND ADDING SUBSECTION D RELATING TO POLICY CHANGE IN CONSUMERS MONTHLY BILLING AND SECURITY DEPOSIT OF THE CODE OF THE CITY OF PARK HILLS, MO.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARK HILLS, MISSOURI, AS FOLLOWS:

SECTION 1.

Section 700.030 Subsection C is hereby repealed and replaced with new subsection C.

SECTION 2:

Section 700.030 Subsection C of the Code of the City of Park Hills, Missouri, is hereby amended as follows:

Bills shall be due and payable at the time rendered, and each bill will be posted with a payment due date. A late fee calculated at ten-percent (10%) of the total dollar amount due will be accessed to any bill not paid in full by the due date. If any bill is not paid in full by ten (10) calendar days after the due date, the City Water Department shall have the right to discontinue service to the customer. In cases that water service is terminated due to non-payment of a bill, it shall not be resumed until such time that the total amount of the bill, the ten-percent (10%) late fee, plus a reconnection fee is rendered in full. In accordance with City Ordinance NO. 1340-19. Section 1 J, "Any consumer requesting water to be turned on who has had his or her water shutoff previously for non-payment must pay any balance due on the prior account and pay a reconnection fee of fifty dollars (\$50.00) if reconnection is during regular office hours of the City Water Department Office. If the meter has not yet been pulled after being shut off, reconnection may be made after regular office hours of the City Water Department Office, in which case the fee shall be one-hundred-twenty-five dollars (\$125.00)". Full payment shall be made at the office of the City Water Department. No partial payment shall be accepted.

SECTION 3:

Section 700.030 of the Code of the City of Park Hills, Missouri, is hereby amended by adding Subsection D as follows:

In the event that a customer fails to rectify the past due bill by fourteen (14) calendar days past the due date, their account with the City Water Department shall be terminated and the security deposit originally posted by the customer to activate the

account will be applied to the City towards the delinquent bill. In order to restore water service, the customer will be required to submit a new application, render the remaining dollar amount of the current total due minus the original security deposit, submit the reconnection fee, and post a new security deposit. Please reference City of Park Hills Ordinance Section 700.050, Deposits, for dollar amounts and guidelines for deposits imposed on customers who are disconnected for violation of rules or for non-payment. Full payment shall be made at the office of the City Water Department. No partial payment shall be accepted.


SECTION 4: CODIFICATION.

It is the intention of the City Council of the City of Park Hills, St. Francois County, Missouri, and it is hereby provided that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Park Hills, Missouri; that the sections of this ordinance may be renumbered or relettered to accomplish such intention; and the words "ordinance" may be changed to "section", "article", or other appropriate designation.

SECTION 5: EFFECTIVE DATE

This ordinance shall be in full force and effect thirty (30) days after its passage and approval by the City Council and approval by the Mayor of the City of Park Hills, Missouri or as otherwise provided by law.
