**A RESOLUTION OF THE MUNICIPALITY OF WESTTOWN
TOWNSHIP, COUNTY OF CHESTER, COMMONWEALTH OF
PENNSYLVANIA,**

APPROVING TRANSFER OF SPECIAL OCCASION PERMIT

#LID63135/SO-8722.

WHEREAS, Act 141 of 2000 (“the Act”), which amends the Commonwealth’s Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the receiving municipality issues a resolution approving the transfer of the license outside the municipality to inside the municipality; and

WHEREAS, amendments to the Liquor Code stipulate that prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of a Special Occasion Permit into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a Special Occasion Permit into the municipality.

NOW, THEREFORE, BE IT RESOLVED, St. Maximilian Kolbe Church, a non-profit (501C3) organization, has requested the approval of the Board of Supervisors of Westtown Township for the proposed transfer of Pennsylvania Special Occasion Permit to its facilities within Westtown Township for the 25th Anniversary Festival being held on Sunday, September 18, 2011 with the understanding that said one-time only transfer must be approved at a later date by the Liquor Control Board.

BE IT FURTHER RESOLVED, that the Board of Supervisors/Council of Westtown Township finds that the transfer of a Special Occasion Permit into Westtown Township by St. Maximilian Kolbe Church will not adversely affect the welfare, health, peace and morals of the municipality or its residents.

BE IT FURTHER RESOLVED, that Westtown Township approves, by adoption of this Resolution, the proposed transfer of St. Maximilian Kolbe Church to be located at 15 E. Pleasant Grove Rd, Westtown Township, West Chester PA 19382.

BE IT FURTHER RESOLVED, that the license transfer is subject to approval by the Pennsylvania Liquor Control Board.
