

**RESOLUTION 2018-04**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF WESTTOWN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AMENDING RESOLUTIONS 2012-02 AND 2017-11 DESIGNATING EMERGENCY SERVICE PROVIDERS**

**WHEREAS**, THE WESTTOWN TOWNSHIP BOARD OF SUPERVISORS is responsible under the Township Code for the public safety of the residents of Westtown Township; and

**WHEREAS**, THE CHESTER COUNTY BOARD OF COMMISSIONERS has requested that Westtown Township provide the Board of Commissioners with a resolution outlining the methods and agencies chosen to fulfill the public safety needs of the emergency communications system of the Chester County Department of Emergency Services;

**NOW, THEREFORE**, BE IT RESOLVED THAT the West Chester Fire Department and Goshen Fire Company of East Goshen, the boundaries between them outlined on the second page, will provide Fire Protection Service.

**FURTHER**, BE IT RESOLVED THAT the West Chester Fire Department and the Goshen Fire Company of East Goshen, the boundaries between them outlined on the second page, will provide Rescue Service.

**FURTHER**, BE IT RESOLVED THAT the Good Fellowship Ambulance of West Chester and the Goshen Fire Company of East Goshen, the boundaries between them outlined on the second page will, provide Ambulance Service.

**FURTHER**, BE IT RESOLVED THAT the Good Fellowship Ambulance of West Chester will provide Advanced Life Support Services (ALS) for the entire Township of Westtown.

**FURTHER**, BE IT RESOLVED THAT the Westtown-East Goshen Regional Police Department will provide Police Protection for the entire Township of Westtown.

The contact persons between said organizations and the Chester County Department of Emergency Services shall be the Township Manager or Acting Township Manager, of Westtown Township, and the Emergency Management Coordinator of Westtown Township, Don L. Verdiani (610-692-1930).

**BOUNDARY DEFINITIONS**

The boundaries for Fire Protection and Rescue Services shall be:

West Chester Fire Department: West of SEPTA Railroad tracks (West Chester-Media Line) north to south border of Westtown Township.

Goshen Fire Company: East of SEPTA Railroad tracks (West Chester-Media Line) north to south border of Westtown Township.


The boundaries for Ambulance Service shall be:


Good Fellowship Ambulance Company: West of SEPTA Railroad tracks (West Chester-Media Line) north to south border of Westtown Township.


Goshen Fire Company: East of SEPTA Railroad tracks (West Chester-Media Line) north to south border of Westtown Township.
